

TERMS AND CONDITIONS- ETNZ Fan Zone 2 x Family Sailing Trips March 2021

1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The promoter is AMP Capital Shopping Centres Pty Limited (ABN 13 001 595 955) of 33 Alfred Street, Sydney NSW 2000 AUSTRALIA
3. Entry is only open to NZ residents. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering this promotion.
4. Employees (and their immediate families) of the Promoter, Bayfair Shopping Centre, tenants and their employees of the promoter and agencies associated with this promotion are ineligible to enter. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. 17. If for any reason a winner does not claim a prize (or an element of the prize) within three months of the determination of the winner of a lottery, the promoter will notify NSW Fair Trading and re-determine any winner of the prize in accordance with the directions of NSW Fair Trading.
